He explained that in addition to being nominated by their principal, the teacher must comply with three basic requirements: having a professional license; having a master's degree or 30 semester hours beyond after first receiving their license; and having at least three years of experience in Shaker or two years in Shaker and having held tenure in a previous school district.

Roll Call: Ayes: Mr. Bliss, Mr. Feeling, Ms. Sutherland, Ms. Levenson. The motion carried.

At this time Superintendent Freeman conducted a public hearing on the issue of the reemployment of Eileen Blattner, Lynn Hutter and Mary Lynne McGovern.

New reemployment guidelines have been established by Ohio law in House Bill No. 95. Under this bill, when a board of education wants to consider reemploying a retiree in the same position held prior to retirement, a prescribed process must be followed.

First, a public notice announcing a public meeting considering the reemployment must be placed at least sixty days prior to the reemployment action (expected to be on May 9, 2006). The Treasurer has certified that such notice was placed in the March 9, 2006 edition of the Sun Press. Second, such public meeting must take place between 15 and 30 days before the reemployment action.

As announced in that notice, the hearing this evening satisfies the second requirement for any member of the public to provide input on the reemployment of Eileen Blattner, Lynn Hutter and Mary Lynne McGovern.

At this time Superintendent Freeman opened the floor to the public to provide input on the issue of these reemployments. There was no comment from the public concerning these reemployments.

Superintendent Mark Freeman introduced Dr. Lynn Cowen, principal of Onaway Elementary School. Dr. Cowen extended a warm welcome to the Board and community.

DISTRICT HIGHLIGHTS

• A team of students from Shaker Heights High School won the District Championship in the second round of Fed Challenge 2006, a monetary policy competition sponsored by the Federal Reserve Bank of Cleveland. The team will travel to Washington, D.C., on April 30 – May 1 to compete for the national championship against teams from other Federal Reserve Districts. Shaker Heights High School social studies teacher **Diana Jones** coaches the Shaker team, composed of **Morgan Grossman-McKee**, **Brandon Hemmelgarn**, **Kelly Jackson**, **Shan Tie**, and **Diana**

Wang, with David Coon as alternate. In eight years of competition, Shaker has won seven division (first round) titles and five district titles. In four appearances so far at national competition, Shaker teams have made it to the semifinals twice.

• Forty Shaker Heights High School students have qualified for Ohio History Day (state finals) in Columbus on May 6 on the strength of their showing in district competition at Case Western Reserve University. Additionally, many students won special recognition and prizes, and social studies department chair **Timothy Mitchell** received the David Van Tassel Award from Case for his contributions to the History Day program.

The top three prizewinners in each category automatically advance to state competition, along with other state finalists designated by the judges. Shaker's award winners were as follows:

- In the Research Paper category, **Aaron Abelson** won first place; **Mark Antal** took second; and **Allen Eckhouse** won the Frank Tesch Trophy from the Cleveland Grays for military history.
- In Individual Exhibits, **Susanna Pretzer** won first place and best overall entry. **Halle Minshall, Meghan Thompson,** and **Jefferson Triozzi** also qualified for the state finals. **Jenna Stahl** won a special prize from the Early Settlers Association of the Western Reserve for local history.
- In Group Exhibits, Allie Emerich, Lauren Lewis, and Hannah Lawrence won first place; Cameron Wilk, Joanna Mitchell, Thomas Bostwick, Michael Triozzi, and Peter Schiraldi took third; Courtney Kinter and Courtney McClelland qualified for the state finals; and Katherine Foster, Emily Tuttle, and Eden Engel-Rebitzer qualified for the state finals and won a military history award from the Cleveland Grays. In addition, two Shaker groups won special prizes for local history from the Early Settlers Association of the Western Reserve: Chris Mawhorter and Bobby Sweeney; and Sam Weir, Cullen Clair, and Will Caldes.
- In Individual Performance, Audrey Gyurgyik won second place and Rebekah Wadsworth was third. In Group Performance, Emily Jennings, Katie Kooser, and Chris Mok won second place and a Cleveland Grays award for military history.
- In Individual Documentaries, **Meg O'Halloran** won second place; **Jaclyn Inglis** won third; and **Natalie Mercer** also qualified for the state finals.
- Five Shaker groups won prizes in the Group Documentaries category: Daniel Streassfeld, Patrick White, Juliet Kibbe, and Alex Grossman-McKee (first); Allison Scharfstein, Kate Haubrich, and Katie Spielman (second); Lauren Weinberger and Michael Stavis Bohl (third); Katherine Stamm and Katie Campbell-Morrison (state finalists); and Thomas Neil, Josh Davidson, and Pierre Stricker-Krongrad (special prize for local history from the Early Settlers Association of the Western Reserve).

All are students of history teachers **Timothy Mitchell** and **Dann Parker**.

- Middle School social studies teacher **Erin Herbruck** and Director of Research and Evaluation **Dale Whittington** were both selected to present papers at the annual meeting of the American Educational Research Association earlier this month in San Francisco. Herbruck, who recently completed a Ph.D. in urban education at Cleveland State University, presented her dissertation, titled "The Social Justice Consequences of State Mandated Teacher Testing." Whittington presented a paper on "Validity, Standards, Alignment, Instruction and Learning"; was the discussant at a session on performance and alternative assessment; and served as program chair for the association's section on evaluation in schools.
- Replacement of old windows is under way at Lomond School, with Fernway and Onaway to follow this spring and summer. The new windows, designed to be architecturally compatible with the vintage buildings, are far more energy efficient than older models and require far less maintenance, ultimately yielding savings in operating costs for energy and maintenance. The project is being funded with proceeds from the bond issue approved in 2004.
- The High School Academic Decathlon team earned the highest team score for mathematics and economics in the state competition at Hiram College on March 25. The team consisted of **Katy Fishman**, **Benjamin Heide**, **Nathan Langhinrichs**, **Christopher Murphy**, **Tejas Nandurkar**, **Samhita Pennathur**, **Bradley Ross**, **Daniel Strassfeld**, **Shan Tie**, **Diana Wang**, and **Patrick White**. The following students earned gold medals: **Diana Wang** (mathematics); **Shan Tie** (mathematics and interview); and **Daniel Strassfeld** (interview). Shan Tie also received a Certificate of Achievement as one of the top overall scorers. The team's coaches are High School Spanish teachers **Les Foote** and **Jose Perez**.
- The Shaker Heights Latin Club members have done it again, returning victorious from the Ohio Junior Classical League competition. The team members are: seniors Andrew Kulinski and Helen Morgenstern; juniors Stephanie Goldfarb, Natalie King, Carolyn Stange, Katie Stamm, and Anthony Lanese; sophomores Susanna Pretzer, Katie Ryan, Cyrus Taylor, and Max Rothman; freshmen Katie Crowley, Allison Lanese, Michael Cowett, Melissa Freilich, and Alex Almasan; and 8th graders Chris Piraino, Pranjal Vachaspati, Miriam Chelimsky, Samantha Goldfarb, and Victoria Goldfarb. In addition, Stephanie Goldfarb became the first student from Shaker Heights to be elected president of the OJCL. Michael Cowett has been appointed Northeast Ohio Gubernator, and he will be in charge of co-ordinating the activities of all the Latin Clubs in the area.
- Mark Antal has won the Earthwatch Student Challenge Award, a scholarship that will enable him to participate in scientific field research this summer. Over 300 students applied; 80 were selected nationwide. Mark will be at the Chevelon Ruin in Arizona, a Hopi archaelogical site. The project is entitled "The Analysis of Structural Burning in an Ancient Hopi Village."
- Shaker Heights won the high school state fencing championship on March 26. The Shaker men's team captured first place and the Shaker women's team tied for first with Dublin Coffman High School. In individual results, in men's foil competition: Shaker's **Stephen Cabrera** took 2nd place and **David Coscarelli** 3rd place. In men's epee, **David Coscarelli** took 3rd place. In women's saber, Shaker fencers **Carolyn Stange** and **Akosua Kernizan** tied for 3rd place.
- Senior **Betsy Hogg** recently filmed a guest starring role on an episode of *Law & Order: Special Victims Unit*. Betsy played Janey Speer, a 17-year-old with Turner Syndrome. a chromosomal condition that exclusively affects girls and women and

typically impedes their physical development. In addition to playing key scenes with series stars, Betsy had the opportunity to work with guest stars including Betty Buckley and Robert Vaughn. The episode is expected to air in October.

- The Shaker Heights City Schools will open their doors to District residents as students once again showcase their musical, theatrical, artistic, and academic talents during this year's Shakerfest celebration, which began on April 5 and continues until May 31. The annual event includes such activities as school open houses; student art shows; band, orchestra, and choral concerts; theatre ensemble performances; displays and demonstrations of student projects; and kindergarten welcome gatherings. Events include:

At this time the Board heard a presentation by Director of Research and Evaluation **Dale Whittington** on her research on "students in the middle" – those who are neither struggling academically nor at the top of the class. The work is based on an examination of the academic and co-curricular records of 202 students whose grade point average placed them in the middle 50 percent of the Class of 2005, plus follow-up interviews with a representative sample of 42 members of the class. Mrs. Johnson joined the presentation in progress. Questions, answers and discussion followed the presentation.

Upon the recommendation of Superintendent Freeman, Ms. Sutherland moved, seconded by Mr. Bliss to approve the Student Wellness Program policy listed below.

STUDENT WELLNESS PROGRAM

In response to the reauthorization of the Child Nutrition and Women, Infants and Children Act, the board directs the superintendent/designee to develop and maintain a student wellness program.

The student wellness program:

- 1. includes goals for nutrition education, physical activity and other school-based activities;
- 2. includes nutrition guidelines for all foods available in the district during the school day;
- 3. provides assurance that district guidelines for reimbursable school meals are, at a minimum, equal to the guidelines issued by the U.S. Department of Agriculture; and
- 4. establishes a plan of implementation and evaluation, including designating one or more persons within the district with the responsibility for ensuring that the district is compliant with federal law.

Development of the student wellness program must be a collaborative effort between parents, **teachers**, students, food service workers, administrators, the board and the public.

Upon the recommendation of Superintendent Mark Freeman, Ms. Sutherland moved, seconded by Mrs. Johnson that the Board of Education adopt the following resolution approving the conversion of the Lakeshore Northeast Ohio Computer Association (O.R.C. § 167.01) to an organizational structure known as a council of governments.

WHEREAS, Section 17 of the Consortium Agreement (O.R.C. §3313.92) between the Board and the Lakeshore Northeast Ohio Computer Association ("LNOCA") provides for termination of that Agreement by resolution of the members; and

WHEREAS, pursuant to O.R.C. Chapter 167, the governing bodies of any two or more political subdivisions may enter into an agreement with each other for the purpose of establishing a regional council of governments for the purposes of promoting cooperative arrangements among its members and between its members and governmental agencies or private persons, corporations, or agencies and addressing problems of common concern; and

WHEREAS, this Board of Education desires to join with other political subdivisions for the purpose of establishing the Lakeshore Northeast Ohio Computer Association ("LNOCA");

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Shaker Heights City School District, County of Cuyahoga, State of Ohio, that:

<u>Section 1:</u> This Board of Education hereby determines that the Consortium Agreement created pursuant to O.R.C. §3313.92 shall be terminated as provided for in Section 17 of the Consortium Agreement which states:

In the event that two-thirds of the boards of education of the Consortium Members, by duly adopted resolutions, determine that the Agreement shall be terminated, the Agreement shall terminate upon the date agreed upon by such boards of education, as provided in those resolutions. The board of education of each Consortium Member shall promptly forward a certified copy of such resolution to the Chairman of the Board of Directors.

The Consortium shall be officially terminated at 11: 59 p.m. on June 30, 2006.

Section 2: This Board of Education hereby declares its intention to join with other political subdivisions to establish, and to become a member of a council of governments in accordance with O.R.C. §167.01, which shall be known as Lakeshore Northeast Ohio Computer Association ("LNOCA").

The council of governments known as LNOCA shall be officially established at 12:00 a.m. on July I, 2006.

Section 3: This Board further authorizes and directs the President of the Board, the Superintendent, and the Treasurer to execute the Agreement regarding LNOCA on behalf of the District to be effective on the 1st day of July, 2006, and to do all other things necessary to carry out the purpose of this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Board and any of its committees concerning and relating to the adoption of this Resolution were taken, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were held, in meetings open to the public or otherwise in compliance with the law.

TREASURER'S REPORT AND RECOMMENDATIONS

Upon the recommendation of Mr. Bryan Christman, Treasurer, Mr. Bliss moved, seconded by Mrs. Johnson that the financial statements for March 2006 (Exhibit T-1) be accepted and placed on file for audit.

President Levenson asked Mr. Christman to review the highlights of the March financial statements. He commented on items as delineated in the financial and miscellaneous briefs and as follows:

- Real Estate Tax Collection No change from prior month regarding the projected \$750,000 below budget.
- <u>Personal Property Tax</u> No change from prior month regarding the projected \$150,000 below budget.
- <u>Investment Earnings</u> The federal funds targeted rate continues to increase. One more raise to 5% is expected in May.
- <u>State Foundation</u> The final result is that the District is on the guarantee for fiscal 2006; therefore, revenue will be at or above the budgeted \$14.3 million, including about \$850,000 of guarantee payments.
- <u>Public Utilities Property Tax Reimbursement</u> We received the 2nd half payment, unfortunately, it was at 85%. The remaining 15% is to be paid before fiscal yearend.
- <u>Salary and Wages</u> We continue to experience favorable budget variances. Overtime was \$26,000 less in March 2006 vs. March 2005 and almost break even YTD this year vs. last. Sick leave severance payments are \$157,000 or 30.3% less than prior YTD.
- <u>Fringe Benefits</u> We are experiencing a favorable budget variance with prescription drugs and possible recouping of a portion of the accumulated reserve in self-insurance fund.
- <u>Utilities</u> March budget amount lowered by the Ohio Schools Council (OSC) from \$108,000 to \$91,000 per month. A gas payment holiday was granted by OSC for the month of April.
- <u>CEI Under-Billing</u> Our consultant is in the process of drafting his report. We are anticipating settling for a lesser amount than what has been assessed by CEI.

Mr. Christman also commented on the following legislative items:

- The State bottom line for fiscal 2006 through March, both the revenues and expenses at the State level are experiencing favorable variances. The bottom line is \$579 million to the good for the State;
- House Bill No. 530, the budget corrections and re-appropriations bill, was introduced, deliberated, passed by both chambers and signed by the Governor within a 17-day period. The bill, which was introduced on March 14, contains many technical changes to House Bill No. 66, the biennial budget for fiscal years 2006 and 2007, and provides for new and continuing bond authority for capital projects. Some of the highlights as relates to the educational arena include:
 - Expands the eligibility criteria of the Ohio Educational Choice Scholarship Program to school buildings in academic watch for three consecutive years.
 - Expands the requirement for school districts to participate in federal breakfast and lunch programs where at least one-fifth (instead of one-third under current law) of the students are eligible under federal guidelines for free breakfasts and lunches.
 - Requires school districts to offer a federal food program for all statemandated summer intervention programs.

- Authorizes school district to levy a voter-approved property tax designed to compensate for reductions in state funding caused by appreciation in real estate values as translated through an increased charge-off.
- Delays until FY 2007 implementation of a second certification of formula ADM in each fiscal year.
- o Clarifies that under the twice-annual ADM reporting, payments to school districts will be based on an annualized formula ADM figure.
- Clarifies that transitional aid payments in FY 2006 and FY 2007 are based on the amount of state funding the district received for the previous year.
- Extends the deadline for the School Employees Health Care Board consultant's report to December 31, 2006 and extends the deadline for the Board's written study to January 31, 2007.
- Gives OBM authority to make transfers to ensure that the School District Property Tax Replacement payments are made and appropriates the necessary amounts.
- House Bill No. 530 was signed by Governor Taft on March 30th, with most provisions taking effect immediately.
