

January 11, 2012

At the annual organizational meeting of the Shaker Heights Board of Education on January 10, 2012, the Board took the following actions:

- Administered the oath of office to newly elected Board members William L. Clawson II and Reuben Harris, Jr.
- Elected Annette Tucker Sutherland as President and Jennifer P. Mearns as Vice President of the Board for the 2012 calendar year.
- Set 6 p.m. on the second Tuesday of each month as its regular meeting time.
- Appointed the Superintendent or his designee as hearing officer for student discipline matters and as District representative to the Ohio High School Athletic Association.
- Dispensed with the adoption of separate resolutions for approving checks.
- Established a Service Fund to cover expenses incurred by Board members in the exercise of their official duties.
- Authorized memberships in the Ohio and National School Boards Associations, the Ohio High School Athletic Association, the Ohio Schools Council, and the OSBA Legal Assistance Fund.
- Authorized participation in the Ohio Schools Council Lake Erie Educational Media Consortium.
- Authorized participation in Cuyahoga County educational programs and in private grant and state and federal funding programs.
- Authorized non-salary remuneration for staff (e.g., awards and refreshments at meetings).
- Authorized the Superintendent to accept staff resignations; to take emergency action if needed; to establish lunch and milk prices and student fees; to select instructional materials, courseware, and textbooks in consultation with the faculty; and to conduct parental notification of the Ohio core curriculum requirements.
- Authorized the filing of real estate complaint documents and student activity contracts.
- Appointed as legal counsel the firms of Squire, Sanders & Dempsey L.L.P.; Brindza McIntyre & Seed LLP; Taft, Stettinius & Hollister LLP; and Wilkerson & Associates Co., L.P.A.; and the City of Shaker Heights Law Department.

The Superintendent reported the following:

- President Obama honored Shaker with a visit to the High School last Wednesday to deliver a speech. Among those in attendance were about 600 students and about 30 faculty members. At the request of the White House, students were selected to lead the Pledge of Allegiance and to sing the national anthem. The High School's jazz combo provided entertainment before the program. This was the President's second visit to Shaker; he held a town hall meeting on health care at the High School in 2009.
- Art students from the High School won fifty-one awards in the 2012 Cuyahoga County Regional Scholastic Art Competition and Exhibition, receiving more honors than any other participating high school group and garnering the highest number of awards received by the High School to date. The awards included 14 Gold Keys, 13 Silver Keys, 18 Honorable Mentions, an American Visions nomination, two Cleveland Institute of Art Awards, two Prizm Art Supply Awards, and a Sue Wall Award for Painting.

A panel of local professional artists and art educators juried the exhibit and selected the awarded pieces. Artwork receiving Portfolio Awards and Gold Key Awards will continue to the national competition held in the spring in New York City. The Scholastic Art Exhibition will remain on display in the Reinberger Galleries of The Cleveland Institute of Art until February 4.

Senior **Spencer Seballos** has been selected to receive the 2012 Gold Medallion Hispanic Heritage Youth Award for Science in the Washington DC region. Created in 1998, the Hispanic Heritage Youth Awards program identifies, inspires, prepares, and positions Latino leaders in the classroom, community, and workforce in meeting America's priorities going forward. Spencer is entitled to an educational grant of \$1,000 and is eligible for a national award.

The Awards are divided into twelve different regions across the country: **Dallas, Houston, Denver, Los Angeles, San Jose/Bay Area, Phoenix, Chicago, Miami, New York/Philadelphia/New Jersey, and Greater Washington, DC.** Three recipients are selected for each category (Gold, Silver, and Bronze medallion) in each of the twelve regions. The categories for 2012 include Business, Community Service, Education, Engineering and Mathematics, Healthcare, and Science.

Woodbury sixth grader Andrew Mohar has won his second Woodbury Geography Bee by responding "Australia" to the question, "Most of Wilkes Land, a vast coastal region in Antarctica, is claimed by which country that once served as a British penal colony?"

Sponsored by the National Geographic Society, the competition is designed to encourage teachers to include geography in their classrooms, spark interest in the subject, and increase public awareness about geography. Woodbury faculty member **Joseph Romano** coordinates the school's competition.

■ Six Shaker Heights High School students, including Kamela Abdul Razzaaq, Mario Belfiglio, Zoe Davidson, Rachel Krause, Alexis Moten, and Jonah Weinstein competed in the fourth annual Shakespeare Competition held at the school on January 6. Zoe Davidson's first place performance of a monologue by Rosalind from *As You Like It* advances her to the Regional Shakespeare Competition, which will take place February 25 at Playhouse Square. Jonah Weinstein and Kamela Abdul Razzaaq were named first and second runners up respectively.

Sponsored by The English Speaking Union (ESU), the competition is designed to help high school students develop their communications skills and appreciation of language and literature through the study, interpretation, and performance of Shakespeare's monologues and sonnets. Students participate in three qualifying stages at the school, regional, and national levels. Winners of the regional competition will go on to compete in New York City in April. The national champion will receive an all-expenses-paid trip to study acting in England.

The year-long Shaker Heights Centennial celebration kicks off on January 21 with a City-sponsored event, "It's a Shaker Thing," at 5 p.m. in the High School's Large Auditorium. Written and directed by Jon Leiken (SHHS '90) and Friends, the program will include appearances by Shaker students, celebrities, puppets, historic figures, public officials, and other surprise guests as well as a screening of the "Shaker Sings Simple Gifts" video. The schools' first major Centennial event will be a concert at 7:30 p.m. on February 15 by the Shaker High Wind Ensemble, Chamber Orchestra, and A Cappella Choir. The groups will perform music representing each decade from 1920 to the present, as well as the world premiere of a new musical

piece by native Clevelander and composer David Conte, with the poem "I Dream a World" by Langston Hughes as the text. The piece was specially commissioned for the event, with support from the Madeline and Dennis Block Fund of the Shaker Schools Foundation. The concert is free and open to the public. - Financial statements and interim investments for December 2011.
- Transfers between funds to support the athletic departments at the High School and Middle School.
- Supplemental appropriations.
- Adoption of the 2012-2013 Tax Budget.
