SUBJECT: Financial and Miscellaneous Briefs

I. GENERAL FUND (As of December 31, 2007)

A. REVENUE

1. Real Estate Taxes:

\$2,663,726 or 11.0% more than taxes received through December 2006. 46.0% of estimated real estate tax collections have been received to date. Last year at this time, we had received 44.5% of the estimated taxes. The current month variance from the prior year is due to the 2nd half settlement received in November of this year, but in December in 2006. The rest of the variance is attributable to the new 9.9 mill levy that began collections January 1, 2007.

The unfavorable budgetary variance is due primarily to the reduction and the conversion of the telecommunication equipment from being classified as real estate to general business property (see also the next item).

2. Personal Property Taxes:

\$38,984 or 3.4% less than the amount received at this time last year. 175.4% of the estimated tangible tax has been received to date. Last year at this time, we had received 90.8% of the estimated taxes. Although this is the second year of the phase-out of this tax in accordance with House Bill No. 66, such reduction is being offset by another provision of H. B. No. 66, which has had the impact of actually increasing our current year personal property tax collections.

The implementation of the House Bill No. 66 provision converting that portion of the public utility telecommunications property that was formerly treated as public utility property (and accordingly included in with real estate tax collections) to being classified as general business property (part of the tangible personal property) began in calendar 2007. Consequently, our personal property tax collections increased this year due to this switchover. The real estate tax collections for calendar 2007 are reduced due to the original phased-in reduction in the assessment percentage of the legacy telecommunications property under the provisions of House Bill No. 95, and beginning in calendar 2008, there will be no more real estate tax collections for telecommunications property. The phase-out of the tangible personal property tax for telecommunications property extends an additional year beyond calendar 2008 (the

last year for regular tangible personal property) in accordance with the provisions of H.B. No. 66.

The tangible personal property tax replacement payments from the State theoretically incorporate the loss of this converted public utility tax to tangible personal property.

Additionally, the exempt personal property payment was received in November last year, but not until December this year.

3. **Investment Earnings:**

\$900,666 received this year, which is \$295,750 or 48.9% more than received at this time last year. 100.1% of estimated interest income has been received to date. Last year at this time, we had received 88.2% of the estimated interest. Cash-basis interest income varies month-to-month and year-to-year due to the varying maturity dates of the investment portfolio. Consequently, the monthly variances may swing from positive to negative throughout the year.

The Federal Reserve last raised targeted short-term interest rates a quarter point to 5.25% on June 29, 2006, and then left them unchanged at each of their nine meetings since then, including on August 7th. In an attempt to promote the restoration of orderly conditions in the financial markets, the Federal Reserve approved on August 17th a temporary 50-basis point reduction (from 6.25% to 5.75%) in the "discount rate", which is the rate banks pay to borrow from the Federal Reserve. This was intended as an alternate move to lowering the targeted short-term interest rates (referred to as the fed funds rate), which is the rate that banks pay to borrow from each other.

Given the continuing uncertainty in the financial markets specifically concerning the mortgage industry, the Fed lowered the Fed funds rate by 50 basis points from 5.25% to 4.75%, at their meeting on September 18th. They also lowered the discount rate from 5.75% to 5.25%. With the continuing softness in the economy caused by the sub prime mortgage collapse, the Fed lowered the Fed funds rate by 25 basis points to 4.50% on October 31st, and to 4.25% on December 11th. Because of the continuing softness in the economy due to the sub prime market collapse coupled with the record price levels for energy (specifically oil which has been hovering around the \$100 per barrel mark), many believe there will be additional rate cuts in the near term.

The yield curve which was relatively flat for an extended period of time and then actually became inverted (short-term rates higher than long-term rates), resulted in reducing the attractiveness of lengthening maturities in the portfolio. There had been some steepening of the curve, although it had remained inverted. With the rate adjustments since August, the short-end of the yield curve has dropped thereby eliminating some of the inversion. We continue to monitor and adjust the maturity length target for the District's portfolio in accordance with our ongoing discussions and consultation with our investment advisors.

4. Other Local:

Last years YTD receipts included the second semester fiscal 2005-06 SF-14 pupil payment from the State amounting to nearly \$646,000, while this years YTD revenue includes the handicapped SF-14 payment for the first and second semester fiscal 2006-2007 and the second semester fiscal 2006-07 SF-14 payment (received in November). Such payments vary with both the number of out-of-district students that are court-placed in our District and the number of days those pupils are enrolled in our District during the school year.

5. State Sources:

Foundation program receipts are \$25,416 or 0.3% less than those of one year ago. 50.5% of estimated Foundation receipts have been received to date compared to 50.9% for last year. It should be noted, however, that the State Foundation payments are merely estimates until the ADM counts are finalized and adjusted starting in January, and as in last fiscal year, with further adjustments for a second ADM count in February.

We continue to be on the guarantee (\$2.7 million as of December) for this year such that our revenue will be approximately the same as last year. We currently are slightly ahead of budget in this category.

6. Other State Sources:

\$320,475 or 42.5% more than the amount received in the prior year due primarily to a \$22,885 increase in 027 and 028 property tax appraisal adjustment payments, and a \$306,948 increase in the House Bill No. 66 scheduled tangible personal property tax loss reimbursement payment over the prior year. Also included in YTD receipts is a \$2,083 refund of the State fuel tax paid on fuel purchases during the second half of calendar 2006. 42.9% of estimated Other State receipts have been received to date compared to 46.1% for last year.

Other State Sources for the current and prior year YTD include a semi-annual public utility property tax reimbursement of \$387,952 and \$388,031 respectively, which as you may recall, is to help offset the reduction in real estate taxes collected due to the lower assessed value applied to the electric and natural gas industry properties.

7. Homestead Exemption and Rollback:

Included in December receipts is \$3,450,707 for the Homestead Exemption and Rollback semi-annual payment from the State. This payment is part and parcel of our total real estate tax collections and is \$436,055 higher than the prior year due to the new 9.9 mill levy that began collections January 1, 2007. Tax collections overall (real estate, personal property and Homestead Exemption and Rollback) are only \$30,839 below budget through the end of the first half of the fiscal year.

8. Federal Sources:

The \$26,828 received in this YTD represents the fiscal year 1999-2000 final settlement for the CAFS (Medicaid reimbursement) program. We are still awaiting the implementation date of the new Medicaid reimbursement program expected to be finalized in the near future including provisions for retroactive coverage to July 1, 2005.

The Auditor of State completed their field audit of our CAFS fiscal year 2002-03 cost report in November. The District received \$364,000 in reimbursement payments in Fiscal 2003. Although we haven't received the final report, it is our understanding that the audit adjustments total less than \$1,000.

9. Total Revenue:

\$3,867,355 or 10.2% more than the amount received during the prior fiscal YTD. 48.8% of estimated income has been received to date compared to 47.2% last year. The variance is primarily due to the higher real estate tax collections.

B. EXPENDITURES

1. Salaries & Wages:

Payroll expenses as of December 31st represent a 4.6% increase from last year's payrolls for the same number of year-to-date pay dates. Payrolls averaged \$2,012,880 for the year-to-date vs. \$1,924,845 for the prior year. Excluding sick leave severance payments, however, the increase is only 3.2% over the prior year, which reflects the cumulative effect of the contractual and step increases that went into effect over the last 12 months. YTD total salaries and wages (including severance payments) are 4.7% above the prior year due to the timing of other fund chargebacks.

Classified overtime paid in December 2007 was \$26,673 more than in December 2006, while the cumulative YTD classified overtime amounted to \$181,644 over prior YTD. Although we are higher YTD than 2007, we are still lower than 2006, our base year of reference. Additional overtime is also required for all of the construction and/or capital related projects undertaken by the District.

Sick leave severance payments this YTD totaled \$487,113, representing a \$322,281, or 195.5% increase over the prior year YTD total of \$164,832. These payments vary from year to year depending on the retirements and whether or not the retiree elects to spread their payments over time up to the maximum of three years.

2. Total Expenditures:

On a cash basis, total expenses were \$1,940,301 or 5.1% more than the YTD expenditure level for the prior fiscal year. This variance is due to a combination of increased costs and timing differences in payments. On a budgetary basis, we have a \$288,684 favorable cash basis variance. However, we have a negative encumbrance variance of \$2.9 million, most of which is attributable to timing differences. We are monitoring expenditures carefully, especially due to the increase in capital-project related expenditures over the prior year.

The encumbrances (\$7,280,872 at December 31, 2007), which include \$3,178,656 for out-of-district tuition, are \$2,864,903 higher than the prior year attributable to: a \$1,040,037 increase in tuition encumbrances, a \$559,140 increase in materials and supplies, a \$10,000 increase in utilities, a \$528,482 increase in repairs and maintenance, a \$255,532 increase in other professional and technical services, a \$333,765 increase in outside pupil transportation, and a \$74,549 increase in all other primary object categories. These differences are attributable to both timing and increases in costs.

II. CONCLUSIONS

- 1. Cash balance reflects an increase of \$6.9 million from that of one year ago. This is due to the \$5.0 million higher beginning of year balance, increased by the \$1.9 million larger excess of revenues over expenditures for the current YTD vs. the prior YTD.
- 2. The following cash deficits are due to a delay in the receipt of State or Federal fund cash requests from the State: Fund 587 \$1,175; and Fund 599 \$40,264.

III. OTHER ITEMS

1. Property Tax Schedule A Analysis:

We recently received from the County Budget Commission, Schedule A information about the final assessed value tax duplicate for the real property tax, and the County's estimate of the personal property assessed value for tax year 2007 (tax collection year 2008). The new assessed values, which reflect the first year after the sexennial reappraisal, decreased \$18.2 million overall for a 1.9% decrease from the prior year level. The decrease consists of a \$3.2 million decrease in residential real estate, a \$4.4 million decrease in commercial real estate, a \$5.2 million reduction in public utility tangible, and a \$5.4 million reduction in tangible personal property.

It is not uncommon for the real estate assessed value to decline in the year immediately after a reappraisal or an update year. The public utility tangible and the tangible personal property declines are a direct result of the impacts of House Bill No. 66 as discussed in sections I.A.1. and 2. earlier in this brief.

The total Schedule A projected general fund revenues are just about \$2.2 million lower than the prior year Schedule A (before adjusting for collection rates). This decrease is attributable to both the declines in tangible personal property and public utility tangible valuation (because H.B. No. 920 reductions do not apply to either public utility or general tangible personal property, reductions in those assessed values result in a reduction of tax revenues, while changes in real estate values result in either increases or decreases to the H.B. No. 920 adjustment factor that equalizes the tax revenues) and the third year of the phase-out of the tangible personal property tax under the provisions of House Bill No. 66.

A summary of the voted and effective millage rates and the assessed values for the 2008 tax collection year is attached for your reference.

2. Tax Budget:

Included with the Board Book for the meeting on January 15th is the proposed tax budget for the fiscal year ended June 30, 2009. The cover letter attached to the tax budget provides an explanation of the process. The change in Ohio law allowing County Auditors to waive the traditional tax budget was implemented by Cuyahoga County five years ago. In accordance with their requirements, the new format in lieu of the traditional tax budget format has been prepared.

We will have the "tax budget hearing" immediately prior to the Board's approval of the tax budget. Please feel free to call me prior to the meeting if you have questions about this process.

3. Real Estate Tax Bills:

As you are aware, the semi-annual real estate tax bills were mailed to taxpayers in December for payments due in January. There were no Shaker local or Cuyahoga County-wide levies passed in 2007 that became effective in 2008. (The Cleveland-Cuyahoga Port Authority renewal levy is effective next year.) Accordingly, there is no levy increase impacting Shaker taxpayers as detailed on the insert enclosed with the tax bill entitled "Why has my property tax bill gone up?" I have attached for your reference a copy of the insert that lists all Cuyahoga County communities and their respective tax increase amounts for a \$100,000 market value home.

4. Property Tax % Allocation:

If it is not escrowed with your mortgage company, you have already received your real estate property tax bill. On the right side of the bill, is a "Tax Distributions" section that lists the breakdown of your tax payment amongst the various taxing entities. The breakdown for the last eight years is as follows:

5. Energy in Education Program Savings:

As you may recall, the District participates in the Ohio Schools Council (OSC) Consortium for its electricity and natural gas needs. The savings achieved as a result of participating in the OSC's second long-term electricity program amounted to \$82,080 or 13.64% of the \$601,850 annual amount for the fiscal year ended June 30, 2007. The savings consist of a 9.48% rate discount and a 4.16% financing discount resulting from the arbitrage gained on the prepayment of the expense.

The savings achieved as a result of participating in the OSC natural gas program amounted to \$4,076 or 0.81% of the \$505,010 annual (school building gas cost only) amount for the fiscal year ended June 30, 2007.

For your reference, I have attached an updated summary of the cumulative savings realized from the District's participation in the OSC energy consortium.

Property taxes are calculated based on the value of your property and the tax rate within your community. Your 2007 property value was used in calculating this tax bill. Most tax increases are due to levies approved by the voters in your community at elections held in 2007.

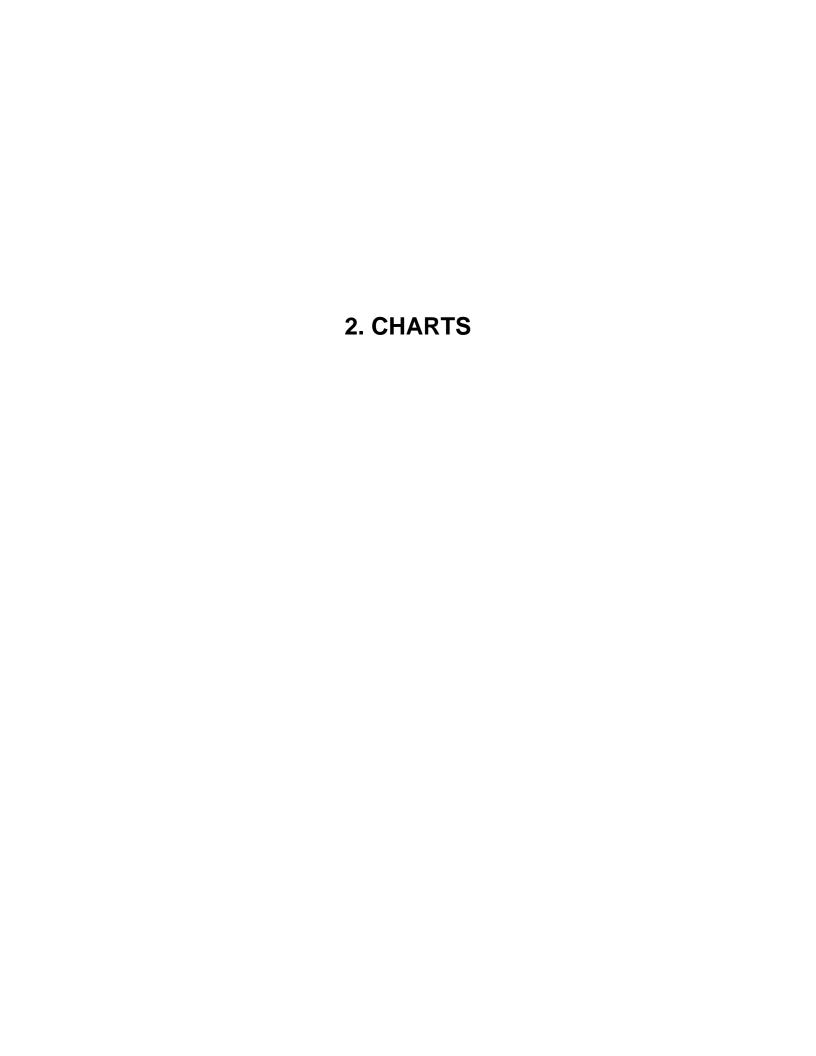
- Senior citizens who became eligible for the Homestead Exemption this year will see a decrease in their tax bills.
- Community Levies Voters in some communities approved school, municipal and library levies during the past year. These new levies are included in your first half 2007 tax bill. Estimated costs for a \$100,000 home follow.
- There were no countywide levies passed in 2007. The renewal levy for the Cleveland-Cuyahoga Port Authority is effective next year.

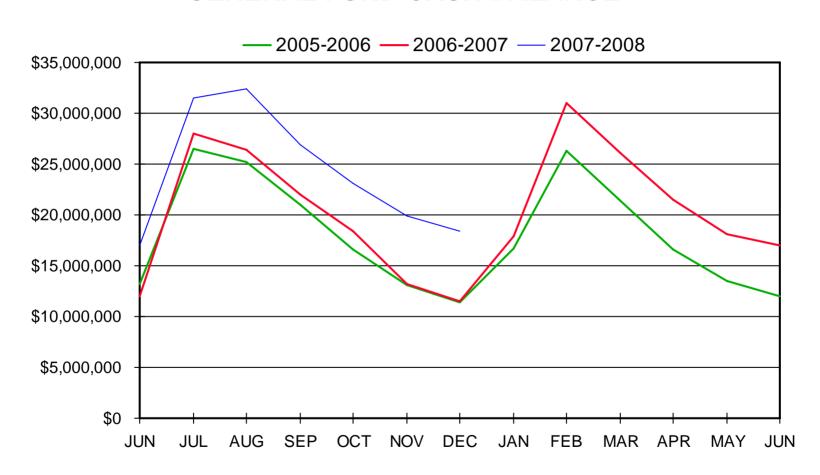

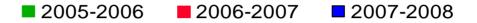

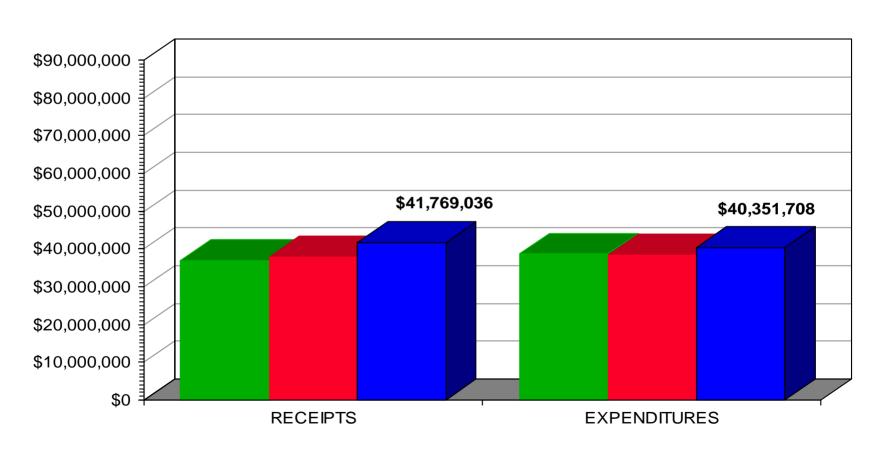


SHAKER HEIGHTS BOARD OF EDUCATION GENERAL FUND CASH BALANCE

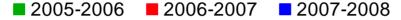


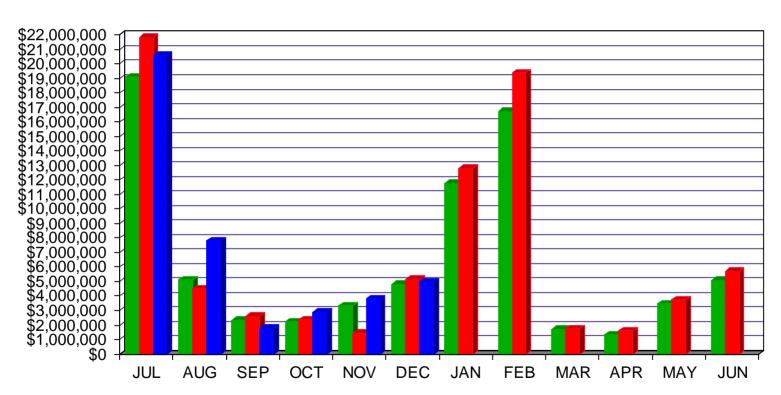

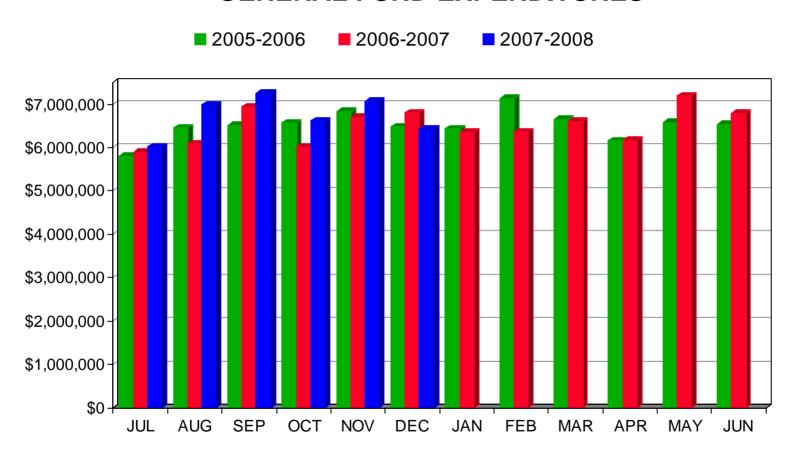


SHAKER HEIGHTS BOARD OF EDUCATION GENERAL FUND RECEIPTS
